New Information

The School Bus Registration or Permit Application (REG 123, REV. 10/2017) form has been revised (sample attached).

NOTE: The prior revision of the REG 123 (REV. 2/2007) will be accepted until January 1, 2018. If a REG 123 is submitted after that date, a Verification of Vehicle (REG 31) form completed by California Highway Patrol (CHP) before December 31, 2017, is required.

Procedures

Continue to follow procedures in the *Vehicle Industry Registration Procedures Manual*, Chapter 21, Special Plates.

Background

On the previous revision of the REG 123, a nonexistent *California Vehicle Code* section was cited.

SCHOOL BUS REGISTRATION OR PERMIT INFORMATION

Please read all sections then complete application on reverse.

Section 1 — Privately Owned School Bus

A privately owned school bus must be operated in accordance with the Rules and Regulations of the Department of Education exclusively in transporting school pupils or school pupils and employees of a private non-profit educational organization. School buses may be used to transport students from activities sponsored by non-profit organizations.

Prior to commercial operation, temporary commercial registration for a privately owned or contract school bus must be obtained. California Vehicle Code (CVC) §545 requires the vehicle to be inspected and approved by the California Highway Patrol for operation as a school bus.

Section 2 — Temporary Commercial Registration for a Privately Owned School Bus

California Vehicle Code (CVC) §9102.5 allows temporary commercial registration for a privately owned or contract school bus. The vehicle operated under this permit must be currently registered under the provision of CVC §9102.5 and is either owned or operated by a private non-profit education organization or privately owned and operated under contract. Vehicle may be used to transport students to or from activities sponsored by non-profit organization.

Section 3 — Temporary Commercial Operation for an Exempt School Bus

An exempt school bus may be registered for temporary commercial operation for one or more calendar months. The vehicle is subject to inspection at any time when operated within this state and assessment of fees and penalties when due.
