**Procedures**

Continue to accept both the old revision (REV. 1/2019) and new revision (REV. 9/2019) of ROS forms until further notice.

**Background**

The REG 51, REG 397, and REG 397A forms have been revised to add a vehicle model field, emphasize important information regarding the attachment of the temporary license plates, and streamline the forms.
