**TECHNICIAN:** Determine current full year fees including Commercial Vehicle Registration Act (CVRA) when applicable and enter in the TOTAL ANNUAL FEES column. For CVRA vehicles, subtract the \$122 Motor Vehicle Fund fee from full year CVRA weight fee before dividing by 4. The \$122 Motor Vehicle Fund fee cannot be prorated. For CVRA vehicles, add the \$122 back to the 25%, for the total CVRA weight fee in the Total FEE DUE column. For all other fees, determine 25% of the annual fee by dividing each portion of the annual fee by 4. Round off to the nearest dollar in TOTAL FEES DUE column.
