A document from the court which reported the violation or conviction; such as a Court Abstract/Document Error form (DL 157), or an original signed or certified letter from the court on official letterhead must be submitted with your request to correct any traffic violation or conviction information. Corrected or amended abstracts from the court are submitted electronically to DMV.**
