Add a Branch Location or Change an Existing Branch Location  Dismantlers are also required to complete an OL 21D and OL 62	<a href="#">OL 21</a>  <a href="#">OL 21D, OL 62</a>	A copy of lease, or proof of property ownership, or rental agreement, BOE Permit (if required), fictitious name statement, location photos and City/County Business License all of which must indicate the new address, and meet all signage requirements. Change Business Name (Doing Business As)  Dismantlers are also required to complete an OL 21D and OL 62	<a href="#">OL 21, ADM 9050</a>  <a href="#">OL 21D, OL 62</a>	Bond Rider (excluding Dismantlers). A new BOE Permit (if required), business License, fictitious name statement, and signage must comply with all regulatory and statutory requirements. ADM 9050 from each named business owner. If adding a retail license form <a href="#">OL 902</a> is also required.	
Change Category <b>CATEGORY TYPES ARE PRINTED ON EACH LICENSE</b>	ADD <a href="#">OL 21</a>	Must provide a Manufacturer's Letter of Approval and Board/Market Area Franchise Notice.	NO FEE
	REMOVE <a href="#">OL 21</a>	At least one category of vehicle must remain	
Close a Main Location	<a href="#">OL 79C</a>	Out-of-Business <b>unless</b> moving main location business activity to an existing branch location	NO FEE
Close a Branch Location	<a href="#">OL 79C</a>	Must be submitted to a local inspection office within 10 days	
Establish or Change your Mailing Address	<a href="#">OL 4000</a>		
US Postal Service mandated firm address change	<a href="#">OL 21</a>	MUST NOT involve relocation to a new address. A copy of the BOE Permit (if required), and City/County Business License that indicate the new address, compliance with all signage requirements and a copy of the Postal Service notice must also accompany the <a href="#">OL 21</a> form. When applicable, an, <a href="#">OL 124</a> letter of authorization must also be provided.	
Change Your True Full Name	<a href="#">OL 12, OL 21, OL 29B, ADM 9050</a>	Copy of your Driver License or other official documents that substantiate the legal name change, BOE Permit (if required), and City/County Business Permit.	\$50
Deceased Owner	<a href="#">OL 29B, ADM 9050</a>	Must submit a Court Appointment as executor / administer, a <a href="#">DMV 8016</a> , a Bond Rider and a certified copy of the death certificate. Once all requirements are satisfied DMV will issue a one year Certificate of Convenience (see VC <a href="#">11720</a> ).	
<b>NOTE: The following modifications are relevant to distributors and manufacturers, but overall completion of the forms and their submission is the responsibility of the associated dealer.</b>			
<b>LINE-MAKE</b> Only	Addition of a line-make to an existing license.	<a href="#">OL 21</a>	NO FEE
	Deletion of a line-make to an existing license.		
	Establish or relocate a satellite warranty facility from same line-make dealer	NO APPLICATION REQUIRED	Board/Market Area Franchise Notice is required if your facility is within 2 miles of a same line-make dealer.
